Required for Federal Grant Eligibility

- **Must have a federally approved Plan in order to receive hazard mitigation funds**
- **Disaster Mitigation Act of 2000 (DMA2K) requires a local plan to be in place for the below programs**
 - Emphasizes a proactive approach to emergency management – prevent damages before the disaster
- **A few types of grants available**
- **Annual:**
 - Pre-Disaster Mitigation Competitive (PDM-C)
 - Flood Mitigation Assistance (FMA)
- **Post Disaster:**
 - Hazard Mitigation Grant Program (HMGP)
 - One of the first questions you will be asked: "Do you have a hazard mitigation plan?"



Ok. We have a plan. So, why are we doing this?

Hazard Mitigation Plans are required by federal law to be updated every 5 years

- McDuffie County's plan approved on **April 27, 2012**
- McDuffie County's plan expires on **April 27, 2017**

What does this plan do?

- Helps you identify the hazards that your county faces
 - Tornadoes, floods, lightning, etc.
 - Only requires natural hazards
 - Can also include technological, or man-made hazards
- Determine the Risk (Threat)
 - How often do you experience these hazards?
 - Very often, sometimes, rarely
- Determine the Vulnerability
 - How bad could the damages get? (dollars, numbers, etc.)
- Develop goals & projects to reduce the risk &/or vulnerability

Updating Your Pre-Disaster Mitigation Plan – The Plan

- Update Risk Assessment
 - What new hazards have occurred since the completion of the previous plan?
 - Has development increased, decreased or remained the same?
 - Are there any changes in your critical facilities?
- Update Goals & Objectives
 - What projects have been accomplished?
 - Are there some that have not been accomplished? Why?
 - Are there new and better ideas?

Updating Your Pre-Disaster Mitigation Plan – The plan itself

- Update the Planning Process
 - Describe the process used to update the plan.
 - Who was involved?
 - How was each section reviewed and how was it determined if revisions were necessary?
 - How did you try to involve the public?
- Update the plan maintenance process
 - What process and criteria will be used for evaluation and monitoring?
 - Did it work on the last plan, or would you maintain the plan differently next time?

Updating Your Pre-Disaster Mitigation Plan – Follow up

- **Submit for GEMA/FEMA Review**
 - GEMA has 30 days, FEMA has 45 day to review
- **Adopt Plan**
 - The county and all municipalities must adopt to be eligible for federal grants.
- **Implement the Plan & Monitor Progress**
 - Ongoing after local adoption and FEMA approval



What is my Part?

- **County Point of Contact**
 - Submit quarterly reports on time
 - Submit for reimbursement as needed
 - Unless a consultant is used, coordinate the planning process and write the plan
- **County, Cities & Towns**
 - County will invite all municipalities to participate in the planning process
 - Participate in planning process & adopt plan
 - Participation & adoption of the plan is **YOUR** responsibility
- **Everyone**
 - Show up to meetings!!!
 - Will ensure your input into the planning process & into identified goals & objectives
 - Will help the County meet the **15%** grant match requirement

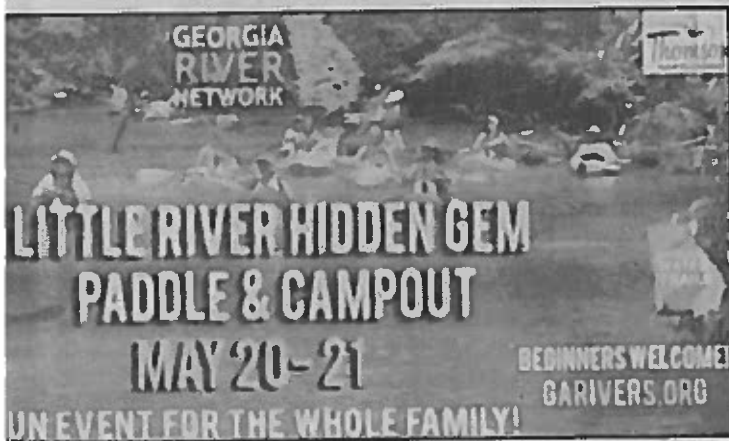
