Like take a vacation.

“We have officers who work security; and, it's for the money,” the sheriff said.

“These men are in law enforcement because they like it. It's not all about money,” Hutchins said. “They sacrifice.”

He said he talked with the county commissioners about giving the deputies and jailers a raise.

“I thanked them and told my men to thank them, too. I appreciate what the commissioners have done. They're all concerned. And I know what they're concerned about,” the sheriff stated and acknowledged the commissioners have to consider the taxpayers and balance their concerns with a strong public safety force.

“We've got to stay competitive,” the sheriff said.

The positions that received the \$1 per hour raise are all correctional officers at the prison, all jailers at the sheriff's office and all deputies and investigators,

The administrator stated the cost of turnover to each of the two departments was difficult to figure; because, there were also savings in costs, such health insurance and changes in employer contributions.

“The \$1 per hour is expected to cost approximately \$184,600. All pay increases went into effect with the new budget on July 1,” he said.

There's another issue caused by the high turnover rate – finding qualified replacements.

“We do have for various reasons a problem sometimes because of past records,” Evans said. “Sometimes we don't have qualified applicants. They don't qualify for POST, don't pass the school. Some of these younger folks get trained, work for us about six months, sometimes a little more than a year and then move on.”

The warden said he talked to the county's previous administrator as well as the current administrator about
